Jill provided the members with a 2015 Budget vs. Actual Report for August 12th 2015. Members accepted.

Jill discussed the Knapp Creek Vehicle insurance with the members. She stated that currently Both, Branch & Hendryx carries the policy but from suggestions from Tom Brady and our attorney, they need to be added to the district's policy. Roy Rogers asked Jill to get the current insured and cash values for the trucks and it will be discussed at the next meeting.

Jill presented the members with the a copy of the Procurement Policy dated May 8th, 1997. Roy Rogers asked Jill to compare this to the suggested policy in the NYS Officers guide and it will be reviewed at the next meeting when the members have a chance to review the current policy.

Jill also asked the members if they have received a status on the roof repairs at the AREMS building. No response yet, Jill will follow up.

Jill also informed the members with the budget information for 2016. As noted by the Town of Allegany, the budget Tax Base Growth Factor is .75%. Jill will be contacting the State Comptroller's Office to confirm the tax figures to use since a portion of the 2016 taxes was returned. She will report back to the members at the September meeting. Rick and Knapp Creek must have their budgets done for the September meeting.

Rick asked the members to approve John Eberth as the grant writer for a NYS Swift Water grant application at \$20 per hour. A motion to hire John to write the grant was made by Roy Rogers and seconded by Bob Wenzel. Board carried.

A motion to adjourn the regular meeting was made by Frank Hall and seconded by Roy Rogers. Board carried.
